Description of Request

We are seeking Legal's assistance in drafting a revised resolution to replace Resolution 24-R-101. The revision is intended to update the non-assessed permit fees in response to the planned increase in the solid waste residential assessment for the upcoming fiscal year. This update is necessary to ensure that out-of-county residents do not pay less than residents in unincorporated Marion County for comparable services. Additionally, we would like the revised resolution to incorporate percentage-based discounts for other government departments and agencies. Both the non-assessed permit fees and discounted rates should be calculated as a percentage of the residential solid waste assessment rate. Basing the fees on a percentage of the residential assessment will eliminate the need to revise the resolution each time rates are adjusted in the future.
