

FIRST AMENDMENT TO THE AGREEMENT

In accordance with the Annual Maintenance of Extrication Equipment Agreement entered into on July 1, 2022, and all of its amendments (if any), collectively (the "Agreement") this First Amendment to the Agreement (this "Amendment") is made and entered into by and between **Southern Rescue Tools, LLC**, whose address is 1021 Parkview Lane, Largo, FL 33778; possessing FEIN **26-0816974**, (hereinafter referred to as "FIRM") and Marion County, a political subdivision of the State of Florida, 601 SE 25th Avenue, Ocala, FL, 34471, (hereinafter referred to as "COUNTY").

WITNESSETH

WHEREAS this Amendment shall remain in full force and effect until completion of all services required of FIRM, and the parties wish to amend the Agreement.

IN CONSIDERATION of the mutual covenants and conditions contained herein, COUNTY and FIRM (singularly referred to as "Party", collectively "Parties") hereto agree as follows:

1. This Amendment shall be deemed to amend and become part of the Agreement in accordance with the project 22SS-136, (the "Project"). All provisions of the Agreement not specifically amended herein shall remain in full force and effect.
2. This Amendment renews the Agreement for One (1) Year, effective July 1, 2025 and ending June 30, 2026 (the "Term").
3. This Amendment replaces the fee schedule reference in the original contract, in its entirety, with the fee schedule hereto.
