

FIRST AMENDMENT TO THE AGREEMENT

In accordance with the Marion County Drainage Retention (DRA) Mowing Agreement entered into on March 19, 2024, and all of its amendments (if any), collectively (the "Agreement") this First Amendment to the Agreement (this "Amendment") is made and entered into by and between **Pure Cuts Lawn & Maintenance, LLC**, whose address is 160 Juniper Trail, Ocala, FL 34480; possessing FEIN 88-4098034, (hereinafter referred to as "CONTRACTOR") and Marion County, a political subdivision of the State of Florida, 601 SE 25th Avenue, Ocala, FL, 34471, (hereinafter referred to as "COUNTY").

WITNESSETH:

WHEREAS this Amendment shall remain in full force and effect until completion of all services required of CONTRACTOR, and the parties wish to amend the Agreement.

IN CONSIDERATION of the mutual covenants and conditions contained herein, COUNTY and CONTRACTOR (singularly referred to as "Party", collectively "Parties") hereto agree as follows:

1. This Amendment shall be deemed to amend and become part of the Agreement in accordance with project 24B-084, (the "Project"). All provisions of the Agreement not specifically amended herein shall remain in full force and effect.
2. This Amendment is effective Effective May 21, 2024, and continues through March 31, 2025. Two, one-year renewals are available, pending mutual agreement. (the "Term").
