**A RESOLUTION OF THE MARION COUNTY BOARD OF
COUNTY COMMISSIONERS, FLORIDA, CONFIRMING
MARION COUNTY’S SUPPORT OF THE BEST FOOT
FORWARD FOR PEDESTRIAN SAFETY PROGRAM; AND
PROVIDING FOR EFFECTIVE DATE**

WHEREAS, Best Foot Forward (BFF) For Pedestrian Safety program, is a communitywide, grassroots initiative to make walking safer by changing drivers' behavior utilizing a "3E" methodology of low-cost Engineering, high-visibility Enforcement and dynamic public Education, measured by increasing driver yield rates at marked crosswalks; and

WHEREAS, BFF is a regional coalition of civic leaders, public safety officials, engineers, transportation planners, educators, health care professionals, advocates, local businesses, and concerned citizens whose mission is to reduce pedestrian injuries and deaths; and

WHEREAS, the Florida Department of Transportation and Marion County recognizes that Marion County has been designated as one of the top 25 counties for pedestrian fatalities within the State of Florida; and

WHEREAS, the BFF program complements Marion County’s Comprehensive Plan, Transportation Element Policy 2.3.5, Complete Streets, Policy 2.3.7, Bicycle and Pedestrian Infrastructure and Policy 2.3.9, Pedestrian Displays as the program supports the goals of creating a safe transportation system for everyone in Marion County.

NOW, THEREFORE, BE IT RESOLVED BY THE MARION COUNTY BOARD OF COMMISSIONERS, AS FOLLOWS:

SECTION I. Marion County’s Support for “Best Foot Forward for Pedestrian Safety.” Marion County supports the principles and practices of “Best Foot Forward for Pedestrian Safety,” and joins with other cities, towns, counties, law enforcement, regional planning agencies and Florida Department of

Transportation in a regional effort to reduce pedestrian injuries and fatalities. As such, Marion County intends to participate in this effort by educating drivers and pedestrians through established constituent communications to support high-visibility pedestrian enforcement actions. These actions will enhance the health and well-being of the residents and visitors to Marion County and contribute to Marion County's goal of creating a safer and more livable community.

SECTION II. Effective Date. This Resolution shall become effective immediately upon its passage and adoption.


