**RESOLUTION TO  
VACATE PORTION OF PLAT  
OF  
SILVER SPRINGS SHORES UNIT NO. 27**

WHEREAS, ATLANTIS VENTURE INVESTMENTS, Ltd., HAS PETITIONED THE BOARD OF COUNTY COMMISSIONERS OF MARION COUNTY, FLORIDA TO VACATE THAT CERTAIN PORTION OF PLAT DESCRIBED AS FOLLOWS:

AS DESCRIBED ON EXHIBIT "A", ATTACHED HERETO AND BY REFERENCE MADE A PART HEREOF.

WHEREAS, ATLANTIS VENTURE INVESTMENTS, Ltd. IS THE OWNER IN FEE SIMPLE OF ALL PLATTED LANDS DESCRIBED ABOVE ( EXCEPT DEDICATED PUBLIC AREAS AS MAY THEREIN BE INCLUDED), AND

WHEREAS, IT APPEARS THAT OWNERS OF PROPERTY IN THE VICINITY OF THE LANDS HEREIN DESCRIBED AND THE GENERAL PUBLIC WILL NOT BE ADVERSELY AFFECTED BY THE VACATING OF SAID PORTION OF PLAT, AND

WHEREAS, PETITIONER HAS CAUSED NOTICE OF INTENTION TO VACATE PORTION OF PLAT ON SUBJECT MATTER TO BE PUBLISHED IN A NEWSPAPER OF GENERAL CIRCULATION, AS REQUIRED BY CHAPTER 177, FLORIDA STATUTES, AND ALL PERSONS THROUGH SUCH NOTICE WERE INVITED TO COMMENT;

NOW, THEREFORE, BE IT RESOLVED, THAT THE ABOVE DESCRIBED PORTION OF PLAT BE AND THE SAME IS HEREBY VACATED AND ALL RIGHTS OF AND INTERESTS OF THE PUBLIC AND OF MARION COUNTY HERETOFORE EXISTING IN THE PLATTED LANDS ABOVE DESCRIBED ARE HEREBY DISCLAIMED AND ABANDONED.





and 28, BLOCK 1887 of said SILVER SPRINGS SHORES UNIT NO.27; and (2)  
those portions of HICKORY COURSE, HICKORY COURSE TRACK, HICKORY  
COURSE TRAIL and HICKORY COURSE PASS south of HICKORY ROAD, that  
portion of HICKORY RUN from the alignment with the lotline between Lot 17 and  
Lot 18, BLOCK 1825 to the intersection of HICKORY LANE, that portion of  
HICKORY ROAD from 50' east of it's centerline intersection with HICKORY LOOP to
