

RESOLUTION 21 R-_____

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MARION COUNTY, FLORIDA, PROVIDING FOR THE ADDITION OF TWO (2) UTILITIES BILLING AND ACCOUNT SPECIALIST POSITIONS, PAY GRADE 8-15, THREE (3) UTILITIES FIELD TECHNICIAN POSITIONS, PAY GRADE 10-16, TWO (2) UTILITIES PLANT OPERATOR POSITIONS, PAY GRADE 8-17, AND ONE (1) UTILITIES PLANT TECHNICIAN POSITION, PAY GRADE 8-16, WITHIN THE OFFICE OF ENVIRONMENTAL SERVICES UTILITIES BUDGETS ZF440536 AND ZF442533; ALONG WITH THE CORRESPONDING JOB DESCRIPTIONS AND PAY GRADES AND INCORPORATING THE FOREGOING ACTIONS INTO THE MARION COUNTY CLASSIFICATION PLAN.

WHEREAS, it is required that all changes to the Classification and Pay Plan must be accomplished through Board approval and resolution; and

WHEREAS, the job description and pay grade for the positions of Utilities Billing and Account Specialist, Utilities Field Technician, Utilities Plant Operator and Utilities Plant Technician are current positions within the Marion County Classification Plan; and

WHEREAS, it is the desire of the Board of County Commissioners of Marion County, Florida, to provide for the addition of two (2) Utilities Billing and Account Specialists, three (3) Utilities Field Technicians, two (2) Utilities Plant Operators and one (1) Utilities Plant Technician in order to effectuate the proper and efficient administration of Marion County Human Resources as specifically provided for in this Resolution.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Marion County, Florida, as follows:

Section 1. The addition of Two (2) Utilities Billing and Account Specialists, Pay Grade 8-15; Three (3) Utilities Field Technicians, Pay Grade 10-16, Two (2) Utilities Plant Operators, Pay Grade 8-17; and One (1) Utilities Plant Technician; Pay Grade 8-16; within the Office of Environmental Services Utilities Budgets ZF440536 and ZF442533; along with the corresponding job descriptions and pay grades, within the Environmental Services Department, is hereby approved.

Section 2. And incorporating the foregoing actions into the Marion County classification plan.

Section 3. Effective Date. This resolution shall take effect May 4, 2021.
