

**FIRST AMENDMENT
MARION COUNTY
STANDARD PROFESSIONAL SERVICE AGREEMENT
State Housing Initiatives Partnership Program**

In accordance with the agreement entitled "Marion County Standard Professional Services Agreement, dated **April 21st, 2020**, (the "Agreement") this First Amendment to the Agreement (this "Amendment") is made and entered into by and between **Central Florida Community Action Agency, Inc. (CFCAA)**, whose address is 411 North Main Street, Suite 210, Gainesville, FL 32601, a not-for profit corporation organized under the law of the State of Florida; possessing FEIN **#59-2113799**, (hereinafter referred to as "SUB-RECIPIENT") and Marion County, a political subdivision of the State of Florida, 601 SE 25th Avenue, Ocala, FL, 34471, (hereinafter referred to as "COUNTY").

WITNESSETH

WHEREAS, the Agreement expired on April 20, 2021; and

WHEREAS, the parties desire to reinstate and extend the term of the Agreement to October 20th, 2021; and

WHEREAS, the parties desire to allow reimbursement requests to be accepted and paid for the term of the Agreement as though the Agreement had not expired, when submitted with proper documentation;

WHEREAS, the parties wish to alter the terms of the Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and conditions contained herein, COUNTY and SUB-RECIPIENT hereto agree as follows:

1. **Incorporation of Recitals.** The Parties confirm and agree that the above Recitals are true and correct, and incorporate their terms and provisions herein for all purposes.
2. **Reinstatement.** The Agreement is hereby reinstated and extended as though it had never expired.
3. **Amended Term.** Paragraph 4 of the Agreement is hereby amended to read as follows:

TERM. The services to be rendered by SUB-RECIPIENT shall commence subsequent to the execution of the Agreement and be completed by October 20, 2021 (the "Deadline Date").

4. **Part of the Agreement.** This Amendment shall be deemed to amend and become part of the Agreement.
5. **In Full Force.** All provisions of the Agreement not specifically amended herein shall remain in full force and effect. Specifically, the funding provided in the Agreement is in no way altered by this Amendment.
