A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF MARION COUNTY FLORIDA PROVIDING FOR THE RECLASSIFICATION OF ONE (1) DIVISION CHIEF POSITION, PAY GRADE 460 TO ONE (1) DEPUTY CHIEF POSTIONS, PAY GRADE 470 WITIN THE EMS DEPARTMENT AA305526; AND THE RECLASSIFICATION OF ONE (1) DIVISION CHIEF POSITION, PAY GRADE 460 TO ONE (1) DEPUTY CHIEF POSITION, PAY GRADE 470, AND THE RECLASSIFICATION OF TWO (2) BATTALION CHIEF POSITIONS, PAY GRADE 450 TO TWO (2) DIVISION CHIEF POSITIONS, PAY GRADE 460, AND THE RECLASSIFCATION OF TWO (2) FIREFIGHTER POSITIONS, PAY GRADE 398-407, TO TWO (2) BATTALION CHIEF POSITIONS, PAY GRADE 450, AND THE DELETION OF ONE (1) FIREFIGHTER POSITION, PAY GRADE 398-407, WITHIN THE FIRE BUDGET EF300522 AND INCORPORATING THE FOREGOING ACTIONS INTO THE MARION COUNTY CLASSIFICATION PLAN.

WHEREAS, it is required that all changes to the Classification and Pay Plan must be accomplished through Board approval and resolution; and

WHEREAS, the job description and pay grade for the positions of Deputy Chief, Division Chief and Battalion Chief are current positions within the Marion County Classification Plan; and

WHEREAS, it is the desire of the Board of County Commissioners of Marion County, Florida, to provide for the reclassification of two (2) Division Chief positions, two (2) Battalion Chief positions, two (2) Firefighter positions and the deletion of one (1) Firefighter position, in order to effectuate the proper and efficient administration of Marion County Human Resources as specifically provided for in this Resolution.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Marion County, Florida, as follows:

Section 1. The reclassification of Two (2) Division Chief positions, pay grade 460 to Two (2) Deputy Chief postions, pay grade 470, Two (2) Battalion Chief positions, pay grade 450 to Two (2) Division Chief positions, pay grade 460, Two (2) Firefighter positions, pay grade 398-407 to Two (2) Battalion Chief positions, pay grade 450 and the deletion of One (1) Firefighter position, pay grade 398-407; along with the corresponding job descriptions and pay grades, within the Fire and EMS Departments, is hereby approved.

Section 2. And incorporating the foregoing actions into the Marion County classification plan.

Section 3. Effective Date. This resolution shall take effect May 22, 2021.
